For family unit of more than 8 members add \$7,606 annually (\$642 monthly) for each additional member.

Explanation on using Matrix for Riverside-San Bernardino County Indian Health, Inc.

Designated staff member reviews applications, checking household income, number of dependents and utility cost to determine dollar amount for which applicant is potentially eligible. For example:

If there is a family of 4 with the gross monthly income of \$1,700 and their utility cost for the month is \$520 the household will be eligible up to \$680 of utility assistance.

If there is a family of 5 with a gross monthly income of \$2,000 and their utility cost for the month is \$895, then the household will be eligible up to \$880; the household will be responsible for the remaining balance of \$10.

This agency verifies the actual utility cost by accepting only the original bill issued by the utility company and contacting the utility company for verification on balance due.
