For family unit of more than 8 members add \$7,724 annually for each additional member.

**Explanation on using Matrix for Riverside-San Bernardino County Indian Health, Inc.**

Designated staff member reviews applications, checking household income, number of dependents and utility cost to determine dollar amount for which applicant is potentially eligible. For example:

If there is a family of 7 with the gross monthly income of \$2,500 and their utility cost for the month is \$510 the household will be eligible up to \$975 of utility assistance.

If there is a family of 5 with a gross monthly income of \$1,000 and their utility cost for the month is \$975, then the household will be eligible up to \$860; the household will be responsible for the remaining balance of \$115.

This agency verifies the actual utility cost by accepting only the original bill issued by the utility company and contacting the utility company for verification on balance due.
