The following EAP program updates are effective for all applications whose household will receive a payment in State Fiscal Year 2020.

- The income guidelines have been updated with the annual update of the federal Department of Health and Human Services Poverty Guidelines.
- The median household energy burden for electricity and heating, when determining the Fixed Annual Credit (FAC) benefit is 1.94%.
- The benefit cap tables for FY 2020 will remain the same as FY 2019 benefit cap tables that became effective April 5, 2019.
- The arrearage assistance burden the applicant must have paid toward their arrearage during the 12 months in which arrearage occurred is 2.13%.
- The utility unit charges and the vendor deduction amounts have been updated with current information.
- The FY 2020 Average/Median Energy Usage by Resident Type & Region chart as outlined in Section 5.5.2 of the Energy Assistance Program Manual.
